Furthermore, we teach clients to become more productive, assure them they are not alone, and point them to Jesus Christ as the ultimate stability and hope for their lives. We go beyond the crisis intervention to provide encouragement and life-skills training to women for months or years as we help them rebuild their lives and grow into mentally, physically, and spiritually healthy women who can support themselves and their children.

Our primary target population includes women in the Illinois and Kentucky regions who are victims of spousal abuse or domestic violence. Our expanded target population includes the United States, Canada and several other countries; we currently have 15 support groups nationwide and have been guests on _______ on the Family with Dr. James Dobson and on the Moody Broadcasting Network.

Need Statement

According to the *American Institute on Domestic Violence*, a woman is beaten every nine seconds in the United States. Domestic violence is in every region of the world. In the United States alone 4,500,000 women each year are physically assaulted according to the *American Institute on Domestic Violence*. The Institute reports over 500,000 women are stalked by an intimate partner each year and 1,232 women are killed by an intimate partner. The great majority of all domestic violence victims are female, and they are more likely to be attacked by someone they know than by a stranger.

According to the *Centers for Disease Control and Prevention* the costs of intimate partner violence against women exceeded an estimated \$5.8 billion in 1995. These costs include nearly \$4.1 billion in the direct costs of medical care and mental health care and nearly \$1.8 billion in the indirect costs of lost productivity and present value of lifetime earnings.

Domestic violence is a serious problem and many women will leave their abuser seven times before they leave for good. Abused women hesitate to leave their abuser due to the fear of risk, self-blame, shame and embarrassment, the need to protect the abuser, dissociation from the pain, denial, and fear of supporting herself and children. Other women remain with their abuser because they feel guilt, live on false hope the abuser will change, believe the children need a father figure, or suffer from post-traumatic stress syndrome.

Our Dress Your Best program provides women with appropriate clothing for a job interview or church attendance; we also provide resume assistance.

We plan to purchase a school building in Kentucky in 2006 to provide the following services: four transitional apartments, health and wellness clinic, family attorney, professional counselor, lay counseling, hair salon, gift and craft shop, art gallery, library/book store, computer lab, Dress Your Best program and satellite seminars. The existing house in Kentucky will be converted into a safe house for emergencies.

In addition to the free literature, we produce 500 copies of a monthly newsletter that is distributed to shelters, crisis pregnancy centers, churches, support groups and individuals. The

newsletter contains inspirational and educational articles to encourage women who are going through difficult circumstances.

We provide training for pastors, church leaders, counselors and support group leaders on domestic violence. In 2004 we provided six trainings. The Train the Trainer seminar is a three day event for women who are interested in starting a _______ support group, or for current support group leaders. We go to churches and provide training on what they can do to meet the needs of women who are struggling and help develop a program for the church. ______ provides support for pastor's wives who are in a controlling or abusive relationship. We provide one-on-one counseling and network them with other pastor's wives in the same situation.

Workshops and seminars and women's conferences on domestic violence are presented to churches, and various organizations throughout the United States. We are available for keynote addresses and seminars and for presentations to small groups. The annual "Restoring the Hope" conference started in 1997 and averages 125 women each year. The conference is a day of encouragement for all women and features a national keynote speaker.

Girl Talk workshops are held on weekends with a sleep over on Friday evening. It teaches teenage girls about dating violence, to spot red flags in dating relationships, and how to set healthy boundaries. Twenty girls attended this workshop. We are currently developing a manual for youth leaders which would include Girl Talk and Guy Talk (a workshop for teenage guys) to be used in churches, schools and organizations.

has 15 domestic violence support groups in six states. The support groups meet anywhere from once a month to weekly. These groups provide a time of

encouragement, sharing, discussion of challenging topics, and fellowship with other women who have found themselves in difficult circumstances.

Our website contains a wealth of information about our organization and materials for women, including free downloads of articles, information on how start a support group, and information on how to request resource materials. The website allows us to reach people, not only in the geographic region of our two locations, but from around the world. The website provides women with the information on how to contact us with questions or to schedule counseling.

Our approach to domestic violence is to educate, inform, train and aid families who are suffering. We are able to accomplish this by all of the programs we have highlighted and we plan to add more programs and services as we continue to grow.

Results and Benefits

Funding ______ will benefit hundreds and thousands of women around the world. Purchasing a building in Illinois and Kentucky to serve as the new women's center will result in transitional housing for victims, more space for group meetings and provide the capacity to service 100 women per month at each location. The expanded library in each center would prove to be a valuable resource as clients will be able to check out books and tapes to educate themselves on various topics. We will expand the Dress Your Best program to accommodate and help 100 women a year to provide them with clothes and prepare them for interviews for jobs.

We will reach more people around the world through our lay counseling. We will increase the number of people we counsel to 2,000 per year in the next few years through various methods, and be able to respond to more e-mails from women all over the world.

will increase the distribution of our free literature to ten countries
and increase our monthly newsletter from 500 per month to 750 within two years. Increases in
both areas of literature will allow us to reach and help even more victims.
Our training for pastors, church leaders, counselors and support group leaders on
domestic violence will grow over time and provide eight trainings per year in various locations.
The annual Restoring the Hope conferences will increase to 200 women in attendance each year.
We will increase the number of Girl Talk workshops to twelve a year and provide service
to 240 girls a year. Our violence support groups continue to grow and we plan to have 25 groups
in sixteen states over the next two years.
With the addition of more staff members and funding we will be able to expand our
operations and provide services to more victims throughout the world. We provide support and
services to the victims for however long they need it to become self sufficient.
Evaluations and Reporting
Evaluation and reporting will be handled by the co-founders of
Ministries and We will provide reports on a
regular basis to the Ministries board and to funders.
The monthly report will document the number of people who access both women's

The monthly report will document the number of people who access both women's centers and the number of customers using the library, Dress Your Best program, and transitional housing. The report will include the amount of literature mailed out and the countries mailed to. Reports will contain the number of trainings, along with locations, and the number of people attending. We plan to implement outcome based measures to show quantifiable data on all of our programs.

Budget Narrative and Justification

The cost to run the organization and the amount requested through this proposal is \$485,578.80. This is broken down into the following categories; Personnel costs, contracted services, office space, travel expenses, materials, equipment, insurance, renovation project and indirect costs.

Personnel costs

The following are personnel costs for the Illinois office. Provide full time Director with an annual salary of \$50,000 to lead the office. Secure a full time Office Manager in the Illinois office at \$40,000 per year to handle all office duties. Bring on board a full time Administrative Assistant at \$30,000 per year to work on all administrative aspects of the office.

The following are personnel for the Kentucky office. Provide the full time Director with an annual salary of \$45,000. Hire an Assistant Director at \$30,000 per year to aid the Director and oversee operations in her absence. Pay for an Administrative Assistant at \$25,000 per year to oversee all administrative aspects of the office.

Pay for a part time Accountant at \$5,000 per year. FICA based on all of the annual salaries listed above at \$220,000 times 7.65 percent equals \$16,830.00. Workers compensation at \$220,000 times 1.5% equals \$3,300. Personnel costs total \$240,130.00.

Contracted Services

Pay for a webmaster to provide services on the website at \$100 per month for twelve months, for a total of \$1,200 per year. The website provides victims information on all of our services and how to contact us for counseling. Contracted services costs total \$1,200.

Office Space

The cost for utilities and phone service for one year of operation at the Kentucky Women's Center is \$7,200.00. The cost of utilities and phone service for one year for the Illinois Women's Center is \$3,500.00. Office space costs total \$10,700.00.

<u>Travel Expenses</u>

Both co-founders attend conferences and seminars throughout the year at a cost of \$20,000 per year. These conferences and seminars are for education in the area of domestic

violence, leadership and theological training. *The Ultimate Leadership Conference* by Drs. Henry Cloud & John Townsend in California, costs approximately \$2,000 each for four employees equals \$8,000. *School of Spiritual Direction* by Larry Crabb in Colorado, costs approximately \$1,700 each for four employees equals \$6,870. A Seminar on Fundraising in Indianapolis, Indiana, costs approximately \$750 each times four employees equals \$3,000. *Leadership Summit* at Willow Creek Church in Barrington, Illinois for eight board members and staff at \$400 each equals \$3,200.

Travel and hospitality at a cost of \$10,400 per year is to pay for all travel expenses to conferences and seminars, and when we are guest speakers at churches or organizations.

Hospitality is for guests and leaders who visit the centers. Travel expense costs total \$30,400.00.

Materials

Postage at \$6,000 per year primarily for the distribution center in Kentucky and used for newsletter, invitations and brochures. Office supplies at \$8,000 per year, toner, paper, binders for manuals, envelopes and other necessary office supplies. Books and videos for the support group training (\$8,000) and library (\$2,000) for a total of \$10,000. Printing is \$6,000 for brochures, manuals, newsletter and invitations. Buy a cell phone service plan for three phones at \$1,600 per year for both co-founders and one other counselor, creating an opportunity to counsel women at any time of the day. Materials costs total \$31,600.00.

Equipment

Buy a copier for each location at \$10,000 each for a total of \$20,000. Purchase a paper folder for each location at \$3,500 each for a total of \$7,000. The paper folder will allow us to fold our brochures internally instead of paying for this service somewhere else. Two computers at each location at \$2,000 each (2x2x\$2,000) equals \$8,000. The computers will allow us to

function more effectively and efficiently, by running financial software and other necessary applications. Two color printers, one at each location at \$700 each. The printers will allow us to print off materials from our office, instead of sending them elsewhere.

An LCD projector and screen at each location at \$2,240 each equals \$4,480. The projector and screen are needed for us to show our information video, or for presentations at the center or at another location. A DVD duplicator is needed at each location at \$1,200 each for a total of \$2,400. The duplicator is used to make copies of our information DVD's that we will hand out to individuals and organizations. Using the duplicator will save us money compared to the cost of having copies mass produced elsewhere. Equipment costs total \$43,280.000

<u>Insurances</u>

Medical Insurance for all employees at both locations is \$21,600. Property and liability insurance for both locations is \$5,000 per year. Car insurance for ______ owned vehicles at both locations. Insurance is \$1,500 per year in Illinois and \$1,200 per year in Kentucky. Insurances costs total \$29,300.00.

Renovation Project in Kentucky

Build an addition that will run the length of the house and is 12 feet wide. We have a room for meetings, a bathroom and more storage space.

A new central air conditioning and heat pump unit for \$10,000 will replace the 25 year old unit. The air and heat unit does not work all of the time. This new unit will also cover the new addition area.

Our windows are old single pane and are painted shut. We want replacement windows at a total cost of \$3,000, which will help with heating and cooling costs. Right now the basement is not useable as there is a gravel floor with a small slab of concrete for the central air condition

and heat pump unit. We want to weatherproof it and finish the floor. This will help cut down on the dampness, which is currently affecting the rest of the house. The total cost of the renovation project is \$63,000.

Total Expenses and Secured Funds

The total cost of the renovation project in Kentucky is \$63,000, will greatly improve the
condition of the women's center. The total operating budget is \$386,610.00 and will allow
Ministries' to touch many sufferers of Domestic Violence. Indirect costs
are figured by taking the subtotal of the items listed above, \$449,610.00 times 8% for a total of
\$35,968.80.

The total expenses are \$485,578.80 per year. We receive close to \$36,000 through fundraising and donations annually. We are seeking \$449,578.80 to complete our funding goals.
